

3 Letter Brand to be held before applying for distinctive brand

A person must hold a registered three-letter brand before he can apply for a distinctive (symbol) brand.

Number of Distinctive (symbol) brands

The owner of a three-letter brand may hold up to three distinctive (symbol) brands.




































Size of Distinctive (symbol) Brands

A distinctive (symbol) brand shall not be less than 4cm high and wide or no more than 12cm high or wide. The imprint surface of the irons is to be no more than 4mm wide and no less than 3mm wide.

A full scale drawing of the required distinctive brand is to be submitted at the time of application.

If, in the opinion of the Registrar or their delegate, a distinctive brand produced from the chosen design would not be clearly legible the distinctive brand will not be registered.
