

# Producer NLIS Infrastructure Scheme

---



The Northern Territory Government and the Australian Government have committed \$1.57 million to support the implementation of the National Livestock Identification System (NLIS) in the NT cattle industry.

Property owners receiving stock will be responsible for ensuring that NLIS devices are read with an NLIS reader and that the RFID numbers are sent to the national NLIS database. This may involve expenditure on new infrastructure such as stockyard modifications, RFID readers, weigh scale indicators, associated software and computers.

Following the purchase and installation of an RFID system, property owners will be able to claim reimbursement for infrastructure expenditure.

The **owner** of each Northern Territory property identified by a Property Identification Code (PIC) which contains more than 1,000 head will be eligible to claim up to \$3,500 as a reimbursement of expenditure on NLIS infrastructure. One claim only may be made per property.

The scheme will be administered by the Northern Territory Cattlemen's Association but is not restricted to members.

The funds will be available for expenditure incurred between 1 July 2005 and 30 June 2008.

## How to Apply

1. Complete the **Application Form – NLIS Infrastructure Scheme** and attach copies of the invoices described on the application form [Page 2].
2. Complete the **Payment, GST Questionnaire and Applicant's Declaration** [Page 3].
3. Complete the **Payment Details Form** [Page 4].
