**** You must sign this form in front of a person who is over 18 years of age. That person must sign here, write his or her name in full and write his or her address and telephone number.**

- (1) It is an offence under section 26 of the *Prostitution Regulation Act* for a person to make a false or misleading statement in an application for the grant or renewal of a licence. Maximum penalty: \$2,000.
- (2) If you require more space to answer any of the questions on this form, please use the back of the page, and sign that page as well.
- (3) You must pay the prescribed fee when you lodge this application. The prescribed fee for the application is \$400, plus \$80 for each business name the agency will operate under.
- (4) An operator's or manager's licence remains valid for 12 months from the date of issue. If you are applying for a renewal of the licence you must do so at least 2 months before the current licence expires.
- (5) If you lodge this application with the Northern Territory Licensing Commission and any of the details you have provided change between the date you lodge it and the date on which that Commission decides your application, you must advise the Director of Licensing of those changes. Penalty: \$2,000.
- (6) It is an offence under section 7 of the *Prostitution Regulation Act* for a licensed operator to carry on an escort agency business in partnership with, or otherwise in conjunction with, a person who does not have a licence to carry on that business. Maximum penalty: \$10,000. If you do so, you will probably lose your licence.
- (7) Once this application has been lodged with the Commission you will be investigated by the Northern Territory Police Force to assist the Commission in its determination of your eligibility and suitability to be granted a licence.

PROSTITUTION REGULATION ACT

NOTICE IN ACCORDANCE WITH THE INFORMATION ACT (INFORMATION PRIVACY PRINCIPLE 1)

Racing, Gaming and Licensing (RGL – a division of NT Treasury) is seeking information from you for the purposes of your application.

Information Privacy Principle 1 (IPP 1) requires that a public sector organisation must not collect personal information unless the information is necessary for one or more of its functions or activities. If personal information about an individual is collected from the individual, the organisation must take reasonable steps to ensure that the individual is aware of certain matters. For the purposes of IPP 1, the following advice is provided.

- You are able to access your personal information that you have provided by making a written request to the Director of Licensing.
- The information is required pursuant to the Prostitution Regulation Act. The Act requires that certain matters must be considered when deciding whether or not to approve an application.
- The information will be kept confidential except as follows:
 - (a) Information may be sought from Police, government agencies, interstate licensing authorities, or referees or other persons nominated by you in the application forms. Information may be released to those sources to the extent necessary to obtain information about you and your application.
 - (b) If a hearing is involved, information will be released to the parties, Commission or the Court, as required.
 - (c) Registers of licences and permits will be maintained and will be made available in accordance with section 42 of the Act.
- You do not have to provide information if you do not wish to do so. However, an application may not be approved if there is insufficient information to properly determine the matter in accordance with the Act.
