RACING & BETTING ACT - GREYHOUNDS
NOTICE IN ACCORDANCE WITH THE INFORMATION ACT
(INFORMATION PRIVACY PRINCIPLE 1)

Racing, Gaming and Licensing (RGL – a division of NT Treasury) is seeking information from you for the purposes of greyhound racing.

Information Privacy Principle 1 (IPP 1) requires that a public sector organisation must not collect personal information unless the information is necessary for one or more of its functions or activities. If personal information about an individual is collected from the individual, the organisation must take reasonable steps to ensure that the individual is aware of certain matters. For the purposes of IPP 1, the following advice is provided.

- You are able to access your personal information that you have provided by making a written request to the Director of Licensing.
- The information is required pursuant to the Racing and Betting Act.
- The information will be kept confidential except as follows:
 - (a) Details may be released to the Darwin Greyhound Association, the race caller, and interstate greyhound control boards or authorities.
 - (b) Registers will be maintained and details concerning a greyhound trainer will be made available to members of the public, on request.
- You do not have to provide information if you do not wish to do so. However:
 - (a) an application may not be approved if there is insufficient information to properly determine the matter in accordance with the Act.
 - (b) failure to give a notification may preclude the dog owner and/or dog from participating in greyhound racing.
