Prostitution Regulation Act

Notes to Application

1. This application must be lodged with your Territory Business Centre.
2. All details are to be completed in block letters.
3. If the space provided is insufficient, please present relevant information on a separate sheet and attach it to this form. You must make sure each attachment is signed by the individual to whom it relates and that you indicate below how many of these pages are attached to your application.

4. You must sign this form in front of a person who is over 18 years of age. That person must sign his or her name, write his or her name in full and write his or her address and phone number.
5. It is an offence under section 26 of the *Prostitution Regulation Act* for a person to make a false or misleading statement in an application for a grant or renewal of a licence. Maximum penalty of \$2000 may apply.
6. The body corporate will not be eligible for an operator's licence if one of its shareholders is a body corporate.
7. You must pay the prescribed fee* when you lodge this application.
8. An operator's licence remains valid for 12 months from the date of issue. If you are applying for a renewal of the licence you must do so at least 2 months before the current licence expires.

9. If any of the details you have provided change between the date you lodge it and the date on which the Commission decides your application, you must advise the Director of Licensing of those changes or face a penalty of \$2000.
10. It is an offence under section 7 of the *Prostitution Regulation Act* for a licensed operator to carry on an escort agency business in partnership with, or otherwise in conjunction with, a person who does not also have a licence to carry on that business. A maximum penalty of \$10,000 applies. If you do so, you will probably lose your licence.
11. Once this application has been lodged, you will be investigated by the Northern Territory Police Force to assist the Commission in its determination of your eligibility and suitability to be granted a licence.
12. Sections 2, 3, 4 and 5 of this application must be completed and signed by:

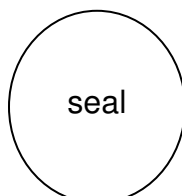

Notice In Accordance with the Information Act (Information Privacy Principle 1)

Licensing, Regulation and Alcohol Strategy (LRAS – a division of NT Department of Justice) is seeking information from you for the purposes of your application.

Information Privacy Principle 1 (IPP 1) requires that a public sector organisation must not collect personal information unless the information is necessary for one or more of its functions or activities. If personal information about an individual is collected from the individual, the organisation must take reasonable steps to ensure that the individual is aware of certain matters. For the purposes of IPP 1, the following advice is provided.

- a) You are able to access your personal information that you have provided by making a written request to the Director of Licensing.
- b) The information is required pursuant to the *Prostitution Regulation Act*. The *Act* requires that certain matters must be considered when deciding whether or not to approve an application.
- c) The information will be kept confidential except as follows:
 - i. Information may be sought from Police, government agencies, interstate licensing authorities, or referees or other persons nominated by you. Information may be released to those sources to the extent necessary to verify information about you and your application.
 - ii. If a hearing is involved, information will be released to the parties, Commission or the Court, as required by the *Act*.
 - iii. Registers of licences and permits will be maintained and may be made available to the public on request.
- d) You do not have to provide information if you do not wish to do so. However, an application may not be approved if there is insufficient information to properly determine the matter in accordance with the *Act*.
