

## LICENSING, REGULATION AND ALCOHOL STRATEGY

### Alcohol in East Arnhem

Alcohol restrictions apply across the East Arnhem area, including the township of Nhulunbuy.

#### What does this mean?

- Drinking is not permitted in public and community places (see list on page 2)
- You can still drink alcohol in licensed premises.
- A Liquor Permit is needed to buy and drink takeaway alcohol.
- You can have alcohol at a special event, festival or function held in a public place if the organiser has obtained a Special Event Permit from the Licensing Commission.

#### When do you need a Permit?

The table below indicates where you can and cannot drink alcohol depending on whether you are a resident or visitor to the area, and whether or not you have a valid Liquor Permit.

# Provided the person holds a valid land permit for the area and possession/consumption of alcohol is in accordance with any conditions on the land permit.

@ For events approved by the Licensing Commission. Invited guests only may drink alcohol at private functions e.g. weddings. For public functions, the Licensing Commission will decide at the time of application and depending on the nature of the event if non permit holders can drink alcohol.

Applications for Special Event Permits must be lodged at least seven (7) working days prior to the event.

### **No drinking in public**

A number of areas around Nhulunbuy have been declared Public Restricted Areas under the Liquor Act. This means that you cannot normally drink alcohol in these areas:
