

## LICENSING, REGULATION AND ALCOHOL STRATEGY

### Greyhound Owner's Registration Certificate

#### What Does This Certificate Allow Me To Do?

You can own and train your own greyhounds for racing in the Northern Territory. Owners may be individuals or syndicates.

#### Are There Any Special Conditions Or Restrictions?

You must agree to comply with all rules and regulations applying to greyhound racing in the Northern Territory. This includes willingness to comply with any conditions imposed by greyhound club officials and stewards for the conduct of race meetings.

Registered greyhound owners are required to notify Licensing, Regulation and Alcohol Strategy of names of greyhounds housed in and removed from their kennels.

Conditions apply to the proper handling of greyhounds in public areas. These are detailed on the registration application form. Owners must also ensure that persons training or handling their greyhounds are properly registered as trainers or attendants.

Owners who wish to handle their greyhound/s at race meetings must comply with standard handling procedures specified by track stewards.

#### What Is The Application Process?

Territory Business Centres provide application forms. Completed forms, whether for individual or syndicate ownership, must be accompanied by the prescribed fee\*.

Information requested on the application form includes:

- greyhound name, kennel address and trainer name;
- details of any previous registration;
- names of any other person/s with monetary or other interest in listed greyhounds;
- greyhound lease details (if any);
- details of any previous disqualifications or other disciplinary actions involving racing authorities; and
- details of any previous offence punishable by fine or imprisonment.

After you have submitted the completed application form, accompanied by the fee, allow five working days for processing.

### **Do I Need Any Special Knowledge, Experience Or Training?**

There are no formal training requirements. However, you should be familiar with the Australian Greyhound Racing Rules.

You may also wish to familiarise yourself with standard handling procedures at any track where you intend to handle your dogs.

### **How Long Is The Certificate Valid And What Is The Process For Renewal?**

The certificate is valid for up to two years with an expiry date of 28 February. To renew your certificate, complete a renewal form and pay the fee.

### **Is The Certificate Recognised Interstate?**

Arrangements exist for mutual recognition of greyhound ownership in other States and Territories. These may vary from time to time. If you are seeking recognition of your registration in another State or Territory, contact the relevant licensing and/or racing authorities in that State or Territory.

### **What If I Have A Comparable Certificate From Interstate?**

To find out about local recognition arrangements, contact Licensing, Regulation and Alcohol Strategy.
