

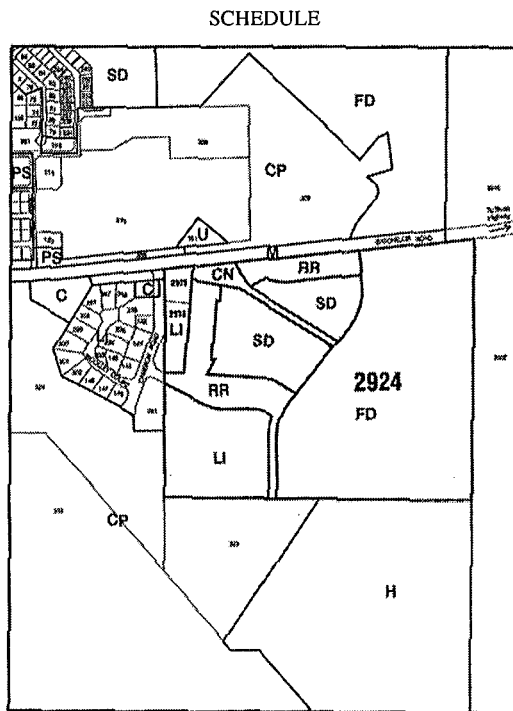

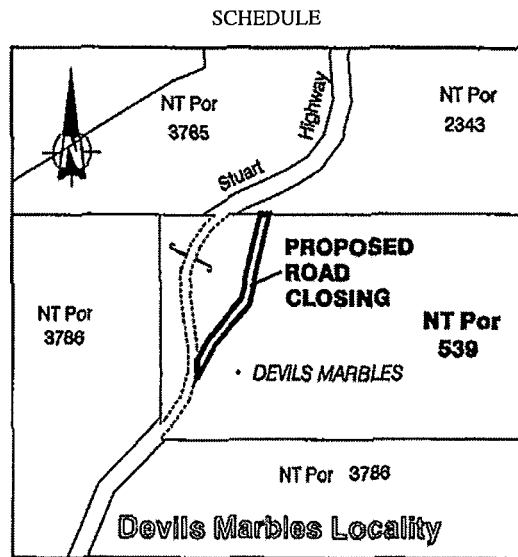

ORDER TO CLOSE ROAD

I, NICHOLA JUNE D'ANTOINE, a delegate of the Minister for Lands and Planning, by virtue of an instrument dated 16 October 2005 made under section 7B of the *Control of Roads Act*, in pursuance of section 32(1) of the *Act*, order that the road shown outlined on the plan appearing in the schedule and more particularly delineated on survey plan S2005/022A deposited with the Surveyor-General, the land contiguous to which is occupied by the Territory, be closed on the date of the first day after expiration of one month after the date of the *Gazette* or the date of the newspaper, whichever is the later, in which this Order is published.

REVOCATION OF TEMPORARY ROAD
RESTRICTIONS

I, PETER FRANCIS TOLL, Regional Manager Darwin Civil, as delegate of the Minister for Transport and Infrastructure, being satisfied the road or part of the road specified in column one of the Schedule, the use of which has been restricted –

- (a) to vehicles the mass of each of which does not exceed the mass specified in column 2 or 3 of the Schedule; and
- (b) in the manner specified in column 4,

is no longer subject to deterioration by the passage of vehicles, pursuant to section 11A(4) and (5) of the *Control of Roads Act*, give notice of revocation of the decision to impose the restrictions from 2.30pm, Wednesday, 28 May 2008.
