REVOCATION OF DECLARATION AND
DECLARATION OF BENEFICIAL USES AND
OBJECTIVES OF WATER
RYAN CREEK

I, NEIL RAYMOND CONN, the Administrator of the Northern Territory of Australia, acting with the advice of the Executive Council -

- (a) in pursuance of section 73(1) of the *Water Act* and with reference to section 43 of the *Interpretation Act*, revoke the instrument of declaration of beneficial uses and objectives of water dated 9 December 1994 and published in *Gazette* No. S58 dated 9 December 1994 at page 1; and
- (b) in pursuance of section 73(1) of the *Water Act*, declare:
 - (i) stock water supply is the beneficial use which applies to the water in that part of the waterway known as Ryan Creek between the point where the waterway intersects with the Zone 52 Australian Map Grid line 8537550N and the point where the waterway intersects with the Zone 52 Australian Map Grid line 8541240N (source 1: 50,000 Topographic Map Series R722, Sheet 5171 1, Edition 2 - AAS);
 - (ii) aquatic ecosystem protection is the beneficial use which applies to the remainder of the water in the waterway known as Ryan Creek not specified in subparagraph (i); and
 - (iii) the objectives for those beneficial uses specified in subparagraphs (i) and (ii) are as specified in tables 5.10 and 2.1 respectively in the document entitled "Australian Water Quality Guidelines for Fresh and Marine Waters" published by the Australian and New Zealand Environment and Conservation Council and dated November 1992.

DECLARATION OF BENEFICIAL USES AND
OBJECTIVES OF WATER
RYAN CREEK

I, KEITH JOHN AUSTIN ASCHE, the Administrator of the Northern Territory of Australia, acting with the advice of the Executive Council, in pursuance of section 73(1) of the *Water Act*, declare -

- (a) stock water supply to be a beneficial use which applies to the water in that part of the waterway known as Ryan Creek extending from latitude 13 degrees 13 minutes South downstream for a distance of 5 kilometres;
- (b) aquatic ecosystem protection to be a beneficial use of the remainder of the water in the waterway known as Ryan Creek not specified in paragraph (a); and
- (c) the objectives for those beneficial uses specified in paragraphs (a) and (b) are as specified in tables 5.10 and 2.1 respectively in the document entitled "Australian Water Quality Guidelines for Fresh and Marine Waters" published by the Australian & New Zealand Environment & Conservation Council and dated November 1992.
