- **Wildlife laws vary between each State/Territory. Therefore, it is recommended that before you consign any wildlife, you contact the relevant interstate Authority about the legal requirements for keeping/importing and exporting wildlife in that State/Territory.**
- Permits are issued subject to the approval of the relevant authority in the State or Territory of Import.
- Export and Import Permits are valid for one (1) consignment only, Import permits are issued for one (1) month and Export Permits are issued for two (2) days.
- When consigning animals' interstate, the consigner must securely attach the original export permit to the cage used in the shipment of these animals.
- Please be advised that this permit is granted under the *Territory Parks and Wildlife Conservation Act* and does not negate the requirement to obtain any authority or permission required under other legislation.
- **Please allow a minimum of Five (5) working days to process your application and a permit to be issued if approved.** Export permits for protected wildlife are printed on special watermark paper and therefore cannot be faxed.
- **Within the last five years have you been found guilty of an offence or had a permit cancelled under the *Territory Parks and Wildlife Conservation Act* or of an offence that relates to wildlife, including similar interstate legislation?**
