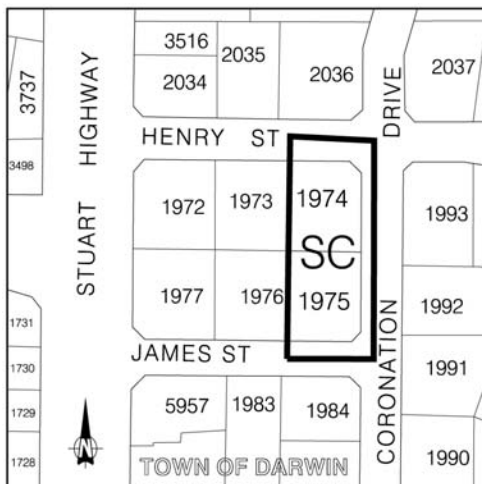

**Stock Diseases Act****AMENDMENT OF NOTICE RESTRICTING ENTRY OR IMPORTATION OF STOCK, STOCK EQUIPMENT AND STOCK PRODUCTS - BEES**
