COMMONWEALTH OF AUSTRALIA

PROHIBITION OF ENTRY INTO A SAFETY ZONE

I, JEREMY PAUL WHITFIELD, Director of Energy, Northern

Territory Department Of Regional Development, Primary Industry, Fisheries and Resources, of the said Territory by instrument of delegation 25 August 2008, and pursuant to section 616 of the above *Act*, hereby prohibit all vessels other than vessels under the register holders of the AC/L9, vessels operated by authorised persons who are exercising powers under Part 6.6 Division 1 section 614 and 615 of the above *Act* and Australian Customs Vessels defined as Commonwealth Ships under the *Australian Customs Act 1901* from entering or remaining in the area of the safety zone without the consent in writing of the Designated Authority of the Joint Authority for the Offshore Area of the External Territory Of Ashmore and Cartier Islands . This safety zone extends to a distance of: five hundred meters, measured from:

Location (GDA94, zone 51)	Latitude 12° 55' 22.72" South
	Longitude 124° 31' 49.22" East
	Latitude 12° 58' 28.41" South
	Longitude 124° 29' 17.94" East

The Safety Zone remains in force for a period of four (4) months from the 10 May 2009.

Where an unauthorised vessel enters or remains in the safety zone specified in contravention of this instrument, the owner and the person in command or in charge of the vessel are each guilty of an offence against section 616 of the *Act* and are punishable, upon conviction, by a fine not exceeding \$100,000 or imprisonment for a term not exceeding 10 years, or both, pursuant to section 616 (3) of the *Act*.

TEMPORARY ROAD RESTRICTIONS

I, PETER TOLL, Regional Manager Darwin Civil, as delegate of the Minister for Transport and Infrastructure, being satisfied Saturated Pavement may make the road or part of the road specified in column 1 of the Schedule subject to deterioration by the passage of vehicles, pursuant to section 11A(3)(a) and (5) of the *Control of Roads Act*, give notice of the following decisions:

- (a) pursuant to section 11A(1)(b) of the *Act*, use of the road or part of the road is restricted to vehicles -
 - (i) the mass of each of which does not exceed the mass specified in column 2 of the Schedule; or

For this notice, "GCM" or an expression relating the specifications for a vehicle has the same meaning as it has under the Motor Vehicle (Standards) Regulations; except that "GVM" has the same meaning as it has under the Australian Road Rules.

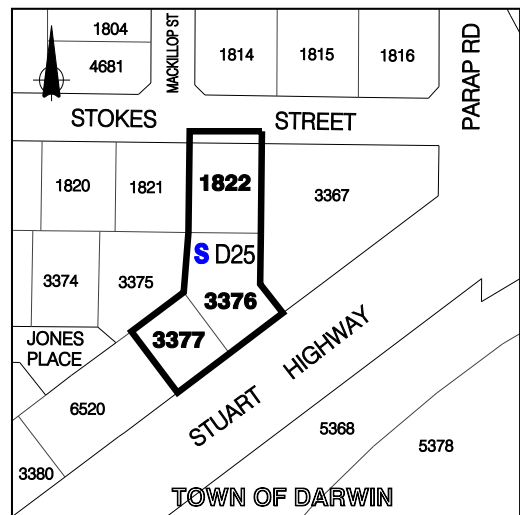
