

**Fisheries Regulations**

## FEES AND LEVIES

I, KONSTANTINE VATSKALIS, Minister for Primary Industry, Fisheries and Resources, with effect on and from 1 February 2011:

- (a) under regulations 206 and 207 of the Fisheries Regulations and with reference to section 43 of the *Interpretation Act*, revoke the notice prescribing fees and levies under the Fisheries Regulations dated 21 May 2010 and published in *Gazette* No. S22 on 24 May 2010; and
- (b) under regulation 206(1)(a) of the Fisheries Regulations:
- (i) prescribe the fee payable for the grant or renewal of a licence specified in Schedule 1 to be the amount specified opposite the licence; and
  - (ii) prescribe the fee payable for the grant of a Timor Reef Fishery licence applied for under regulation 218(1) of the Regulations to be \$3 185; and
  - (iii) prescribe the fee payable for the grant of a Timor Reef Fishery licence applied for under regulation 218(2) of the Regulations to be \$1 592; and
  - (iv) prescribe the fee payable for the grant of a Timor Reef Fishery licence under regulation 141E of the Regulations to be \$1 015; and
  - (v) prescribe the fee payable for the renewal of a Timor Reef Fishery licence to be \$1 015; and
- (c) under regulation 206(1) of the Regulations, prescribe the fee payable for a matter mentioned in Schedule 2 to be the amount specified opposite the matter; and
- (d) under regulation 207(1) of the Fisheries Regulations, prescribe a levy of \$765 to be paid by an applicant for the grant or renewal of a licence listed in Schedule 3 of the Regulations, other than for the grant of a Timor Reef Fishery licence applied for under regulation 218(1) or (2) of the Regulations.
