Do not give this Notice of Disposal to the buyer(s). It is to be completed and sent to MVR by you, the seller within 14 days from the date of sale or a fine of \$2000 (Companies \$10 000) or 6 months imprisonment may apply. **You may still be responsible for the vehicle, including liability for any parking infringements and/or traffic offences (including demerit points where applicable), until this Notice is accepted by MVR. For your protection, you should send this Notice to MVR legibly completed to avoid delay in the processing.** You should also use this Notice to advise MVR when vehicle has been written-off, given/sold to wrecker, etc.
