INTRODUCTION

Purpose

This Guidance Material has been developed by the Australian Rail Safety Regulators Panel (RSRP) in consultation with representatives of tourist and heritage railway operators.

It is intended to assist tourist and heritage railway operators develop Safety Management Systems (SMSs) which comply with State and Territory rail safety laws, including:

- the National Accreditation Package; and/or
- AS4292.1:2006 Railway safety management - general requirements.

Operators should consult their local rail safety regulator on implementation timeframes for these new SMS standards in their State or Territory.

Overview of the Guidance Material

The Guidance Material consists of:

- a **sample Safety Management System** (SMS) for a fictional heritage railway operator in the form of a Rail Safety Management Plan and
- supporting resources including
 - examples of policies, procedures and standards
 - template documents and forms.

How to use this Guidance Material

All tourist and heritage railways are different, and their SMSs must reflect the nature and scale of their operations. This guidance material may be used to:

1. **Review**, in consultation with workers, your existing SMS against the Guidance Material sample SMS;
2. **Identify and prioritise** the components of your SMS which need further development or review; and
3. **Adapt and modify** the Guidance Material relevant components of the sample SMS and the supporting resources to suit your operations.

National Model Rail Safety Legislation

All States and Territories are committed to adopting model rail safety legislation and regulations which are being developed by the National Transport Commission (NTC). It is anticipated that these will be finalised by the end of 2006 and adopted by all States and Territories by mid-2007.

The NTC has indicated that national model SMS regulations will be based on the National Accreditation Package and AS4292.1:2006.

Review of the Guidance Material

The RSRP will review this Guidance Material in 2007 in order to:

- ensure consistency with the national model legislation and regulations; and
- incorporate comments and suggestions from regulators and operators.
